- I would love to join an International Forum on Quality & Safety in Healthcare tour should it be organized. I found the program to be extremely informative.




Did your knowledge of checklists improve?








Lecture 2: Patient Safety – How one learns from other sectors in society / Rein Willems


Did your knowledge of patient safety improve?




Did you find Mr. Willem's lecture easy to understand?




Lecture 3: Radical collaborations catalyzing a revolution in health / John Moore


Did your knowledge of patient safety improve?
